We hope this group of members from various chapters will reduce absenteeism in the area, and promote a healthy cross-chapter networking opportunity for everyone involved.

IF YOU ARE SEEKING A SUB:

- 1) The Sub Directory should not be your first course of action in seeking a sub. Each member should cultivate potential subs from almost any area of his/her life: spouses, family members, employees, regular customers whom you'd like to introduce to BNI, etc.
- 2) Think about developing reciprocal subbing relationships with a few other BNI members, so you will all have other members you can depend upon when you need a sub.
- 3) Please respect the contact information given for each sub.
- 4) Consider seeking out persons whose professions are not currently represented in your chapter, as this offers your sub an opportunity to promote his/her business since there is no direct conflict in your chapter.
- 5) Be sure to notify your VP that you are sending a sub and let them know who will be coming in your place.
- 2) Please give as much notice as possible when you request a sub to take your place. Occasionally there will be emergencies, but most of us know in advance when we are taking an out of town trip or have an appointment that simply cannot be made at any other time. (Your BNI chapter should be your best business appointment!) So, call your sub candidate as early as you can. Be sure to be considerate of his or her time and other obligations.
- 3) Take some time to coach your sub, and if possible, give them a script with your hook if you have one. A follow up reminder call before your chapter meeting time may be in order, too. If you have enough lead-in time, this would be a great opportunity for a one-on-one with another business professional! Remember: givers gain!

IF YOU ARE OFFERING YOURSELF AS A POTENTIAL SUB:

- 1) **You must submit a BNI Sub Directory Listing form** and your membership must be in good standing.
- 2) We ask that you respond to every request either via email or phone, even if only to say you are not available.
- 3) We reserve the right to remove you from the Sub Directory if we receive 3 or more reports of your failure to respond to requests for a sub in a timely manner, or if your membership is not in good standing.
- 4) Remember that, when you sub for another member, you will be doing his or her 60 second.
 - a. Introduce yourself, say who you are subbing for, and do his/her presentation as though you were that person (as much as possible!) You are there primarily to represent him or her, not yourself.
 - b. Be sure to pass out any referrals the person you are subbing for gave to you, and to collect any given to him/her.
- 5) Regarding the 60 second presentation(s):
 - a. Check with the chapter President before the meeting to verify that your business is not in direct conflict with another member in that chapter.
 1. **If you are in a business that is a direct conflict, please mention only your name and company. DO NOT DO YOUR PERSONAL 60 SECOND PRESENTATION IF THERE IS A DIRECT CONFLICT.**

If there is NOT a direct conflict, then you may do YOUR 60 second presentation last, after the whole chapter has done so. ***ONLY BNI MEMBERS MAY DO A 60 SECOND. ANY SUBS WHO ARE NOT BNI MEMBERS MAY NOT PROMOTE THEIR BUSINESS.**
